#### What information about me will you collect and why?

The main form of data we will collect from your child will be photographs and videos taken to record the project process and during community activities. Pictures and photographs will be used in our blog post, where people will be able to see the work we have done for the powerhouse, and follow the development of the project. All videos and photographs will be anonymised prior to being published on the blog.

#### How will my information be stored and how will you look after it?

Data collected from your child in the form of submission, will be anonymised. All datas of the submission will be securely stored in One Drive facilities provided by the Manchester Metropolitan University, and will be immediately removed from any other devices once transferred to the secure One Drive at the end of each session.

#### How will you use my information?

The data and information we collect from your child will be used to illustrate the community having played an active role in our design project, primarily through our published blog. Your child's contributions will be anonymous, which may be uploaded to the blog.

#### Will my data be sent anywhere else, or shared with other people or organisations?

Your child's information will not be shared with anyone other than our collaborators of Levenshulme Old Library.

Any information shared with these organisations will be anonymous. Your child's data will be stored securely in encrypted files, using One Drive facilities provided by the Manchester Metropolitan University. Your child's data will not be shared with anyone outside of the UK.

Data protection legislation requires that we state the 'legal basis' for processing information about you. In the case of research, this is 'a task in the public interest.' If we use more sensitive information about you, such as information about your health, religion, or ethnicity (called 'special category' information), our basis lies in research in the public interest. Manchester Metropolitan is the Controller for this information and is responsible for looking after your data and using it in line with the requirements of the data protection legislation applicable in the UK.

You have the right to make choices about your information under the data protection legislation, such as the right of access and the right to object, although in some circumstances these rights are not absolute. If you have any questions, or would like to exercise these rights, please contact the researcher or the University Data Protection Officer using the details below.

You can stop being a part of the study at any time, without giving a reason. You can ask us to delete your data at any time, but it might not always be possible.
